

UNION ROAD SANITARY SERVICING

PUBLIC INFORMATION MEETING

FEBRUARY 19, 2025

PROJECT LIMITS AND SCOPE

The sanitary sewer installation will occur within the following limits:

- Union Road from Talbot Line to the proposed Wastewater Treatment Facility approximately 1.1 km southeast of Shedden.



This project scope will include:

- New trunk sanitary sewer installation to allow for future servicing within Shedden to the new Wastewater Treatment Facility
- Storm sewer replacement in areas impacted by sanitary sewer installation
- Watermain replacement in areas impacted by sanitary sewer installation
- New curb, gutter and sidewalks in locations impacted by the sanitary sewer installation

SCHEDULE

The proposed schedule is as follows:

- Tendering (January 2025)
- Project Update Meeting (February, 2025)
- Construction (Spring 2025 to Fall 2025)
 - A. Limited storm sewer construction
 - B. Complete sanitary sewer construction
 - C. Limited watermain construction
 - D. Complete road construction to base asphalt including curb and gutter, as well as targeted sidewalk and boulevard restoration
- Surface asphalt and final deficiencies (Spring 2026)





WHAT CAN I EXPECT DURING CONSTRUCTION?

- Considerable disruption, full closure of project limits;
- Access to properties will be maintained with some minor interruptions;
- Emergency access will be maintained at all times;
- Contractor will assist with recycling/garbage pick-up;
- Deep trench excavation for sewer installation;
- Compacted temporary gravel and/or asphalt sidewalks and ramps
- Short-term disruption to water service

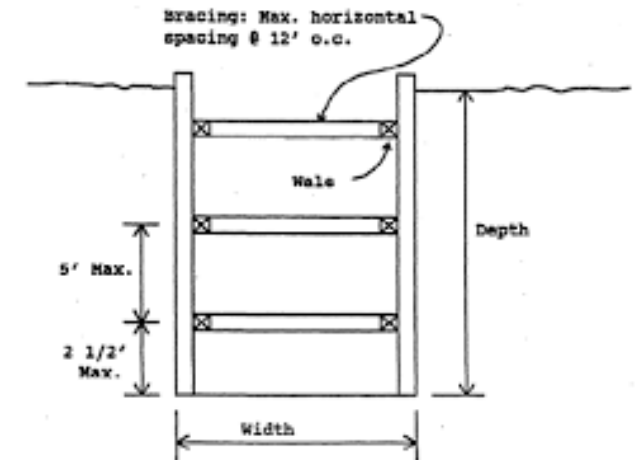
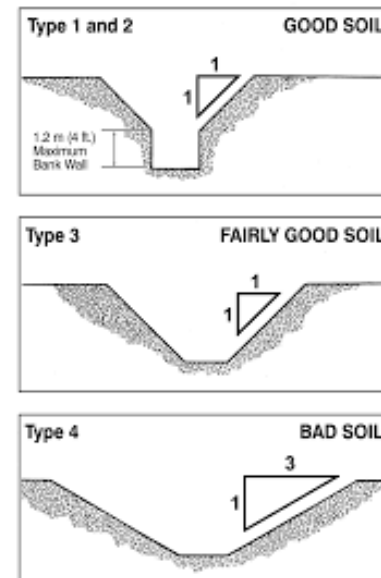




Trunk Sewer Excavation – Trench Box



A trench box system will be used to complete the sections of deep sanitary sewer installation to mitigate health and safety risks during construction. One of the benefits of using this method is the reduced excavation footprint.



Tree Protection



- Tree protection fencing will be installed and maintained around trees located within or in close proximity to the working area to protect trees from damaging during the duration of the construction
